CODE OF CONDUCT FOR LEARNERS AT MVENYANE S.S.S.

DEALING WITH MISCONDUCT LEVEL 1.

MISCONDUCT INSIDE THE CLASSROOM

- > Failing to be in class on time
- Bunking classes
- > Failing to finish homework
- Failing to respond to reasonable instructions & bell
- > Being dishonest
- Disruptive in class
- Disrespect for possessions of teachers and learners
- > Breaks the dress code of the school(no madiba style, no hats), hair must be kept
- > short (brush cut) and No waves
- Negative attitudes
- > Late coming to school
- No gold teeth are allowed

EXAMPLES OF DISCIPLINARY ACTIONS: carried out by Class teacher

- Verbal warnings/Caution or reprimand
- > Small menial tasks like tiding the classroom, cleaning playground etc
- Not permitted to participate in extra-mural activities etc
- > Stay in after school or during break
- Detention recommendation if the above transgressions have serious consequences
- Any learner who is late (in the morning) will not be allowed into school until the
- following day except those learners who use scholar transport.

LEVEL 2

MISCONDUCT BY BREAKING SCHOOL RULES:

- Frequently repeating level 1 misconduct and not responding to disciplinary
- > measures taken by the Class educator
- Smoking or carrying tobacco
- Leaving school without permission
- Using abusive /vulgar language
- Interrupting education in the classroom
- Showing disrespect
- > Engaging in minor vandalism e.g. graffiti, writing on walls and school furniture
- Being dishonest with more serious consequences
- > Is absent frequently without valid reasons
- Fighting

DISCIPLINARY ACTIONS: Carried out by HOD, DP or Principal

- Any of the disciplinary actions listed in level 1
- > Disciplinary talk with the learner by educator and immediate senior
- > Talks with learner's parents or guardians-depending on the offence can be
- > conducted by educator, HOD, DP, or Principal
- > Performing duties that improve the school environment such as cleaning, gardening
- or any other duties
- Detention

Written warnings issued by DP or Principal

LEVEL 3

SERIOUS MISCONDUCT OR SERIOUS VIOLATION OF SCHOOL RULES:

- Frequently repeating level 2 misconduct
- > Inflicting minor injury on another person
- Gambling
- Being severely disruptive in classes
- Forging documents or signatures with minor consequences
- Using racist, sexist or other discriminatory language or acts
- Possessing or distributing pornographic material
- Possessing dangerous weapons
- > Theft
- Vandalism
- Cheating during exams
- Trespassing/being found beyond boundaries

EXAMPLES OF DISCIPLINARY ACTIONS CARRIED OUT BY THE PRINCIPAL

- Any of the disciplinary actions listed above
- Written warning of the possibility of suspension from the school
- > Referral to counselor or a social worker
- Performing duties

LEVEL 4

VERY SERIOUS MISCONDUCT OR VERY SERIOUS VIOLATIONS OF SCHOOL RULES:

- Repetition of level 3 misconduct where disciplinary actions have been ineffective
- Threatening another person with a dangerous weapon /toy
- Causing intentional limited injury to another person
- Verbally threatening the safety of another person & swearing
- Engaging in sexual abuse such as grabbing, touching
- Engaging in sexual activity
- > Selling drugs
- Possessing or using alcohol or drugs or being under influence of narcotics
- Disrupting the entire school e.g. boycotting, pickets, holding illegal meetings
- > Forging documents or signatures with serious consequences
- Possessing cellphone within school premises.
- Threating, insulting, disrespecting and shouting at a teacher.

EXAMPLES OF DISCIPLINARY ACTIONS CARRIED OUT BY THE PRINCIPAL AND SGB:

- Any of the disciplinary action listed above
- Referral of learner to an outside agency for counseling
- Suspension
- Expulsion recommended by HOD of Department of Education

BREACH THE LAW:

- Repetition of level 4 acts
- > Intending to inflict major physical injury on another person
- Intentionally using a dangerous weapon
- Sexual harassment
- Sexual abuse
- Robbery
- Engaging in sexual activity/public indecency
- Major theft
- Breaking and entering locked premises
- Murder

EXAMPLES OF DISCIPLINARY ACTIONS FOR CRIMINAL ACTIONS –CARRIED OUT BY THE PRINCIPAL AND THE SCHOOL GOVERNING BODY TOGETHER WITH THE PROVINCIAL EDUCATION DEPARTMENT

- > Application to the provincial Education Department for expulsion
- Allow for criminal or civil prosecutions which may follow
